

Busch Gardens Williamsburg Valentine's Day Ultimate Date Giveaway Official Rules

NO PURCHASE NECESSARY. A purchase will not increase your chance of winning.

Eligibility. The Busch Gardens Williamsburg Valentine's Day Ultimate Date Giveaway (the "Sweepstakes") is open to citizens and legal permanent residents of the United States including the District of Columbia who are at least 18 years of age at the time of entry. The Sweepstakes is void where prohibited by law. Employees of Sponsor, any prize provider(s), Facebook, Instagram, and each of their parents, subsidiaries, affiliates, advertising and promotion agencies, wholesale distributors, and individual retail licensees, as well as the immediate family and household members of each of the aforementioned, are ineligible to participate in the Sweepstakes. Sponsor's servers and clock shall serve as the official clock for the Sweepstakes and participants' proof of submission does not constitute proof of receipt by Sponsor.
